Items for Discussion

1	<p>Leave and Benefit Surcharge Changes</p> <ul style="list-style-type: none"> A summary document of how all line offices are going to be handling the Leave and Benefit Surcharge changes was provided. For those LO Admins who asked for changes to be made within MARS, a CCR will need to be submitted. There is now a requirement for recording comp and credit earned starting in pay period 19 and it will be stored separately; a CCR will need to be submitted for this as well. There will be a data call to all line office to determine how their OPT will be impacted.
2	<p>Prompting to Exclude Allotments</p> <ul style="list-style-type: none"> The ability to freeze allotments at any given point is available. This is similar to what already exists for BOPs.
3	<p>CCR Review 1294, 1296 & 1297</p> <ul style="list-style-type: none"> 1294 – Voted on by the two line offices present (OAR & NMFS). The CCR was approved. 1296/1297 (duplicate CCRs) - Voted on by the two office present (OAR & NMFS). The CCR was approved.
4	<p>New Report Category – Variance Reporting</p> <ul style="list-style-type: none"> An FYI for the Council - Flux Reporting has been moved to a higher level within the higher level review category and NOAA Variance Reporting is its own category. This was discussed and agreed to at the MARS Council meeting a few months ago.
5	<p>Updated User Access Form – FOTOS</p> <ul style="list-style-type: none"> For those who use the Foreign Travel Numbering System, it has now been incorporated into the DE module of MARS. The New user form has been updated accordingly. A demo on the FOTOS system will be done at the next MARS Council meeting.

6	<p>Help Desk Form – Follow Up</p> <ul style="list-style-type: none"> It was suggested at the last MARS Council that since some users were emailing the Help Desk and not providing enough information, that the email link on the MARS web page (MARS.Support@noaa.gov) auto-populate the email client with a form that users fill out so MARS support have the information required to begin troubleshooting. Since there are too many email clients that are used, this is not a viable option. The solution the team came up with will be an online form on the MARS web page that users fill out; this will essentially serve the same function and will email the information to the MARS Help Desk to initiate a ticket. Development of this form should be completed by the end of Sept 09.
7	<p>CBuy/CREquest Status</p> <ul style="list-style-type: none"> The MARS development team is continuing to work on CBuy/CREquest reporting and have obtained a copy of test data. The development team will take into consideration all Council requests received. Development of this should be complete by the end of this calendar year.
8	<p>Next MARS Council Meeting</p> <ul style="list-style-type: none"> There will not be a MARS Council meeting in September due to fiscal year-end activities. The next Council meeting is scheduled for October 15, 2009.
