1 Update on the Department of Commerce (DOC) Execution Report and the Table of Organization (TO)

- DOC went through the first cycle for March. The NOAA Variance Reporting will support the DOC Execution Report for June. It will not include Personnel data until FY 11.
- At the TO meeting a few months ago, there were a number of questions on how to count positions. Steve Gallagher is asking DOC for further guidance.
- It was suggested that we have a start and end date for positions in the TO. We don't have a method to map the Personnel data to the Budget Program Groups. The TO working group and budget folks need to get together to find a solution.
- Adding budget data/funding source to the TO cleanup would add to the 20 working days response. It was agreed to inform everyone on that data call that funding source information will be needed in the coming months. We will add program code to the spreadsheet that is sent out.

Marina provided a presentation and highlights of the changes include: JInitiator is not going to be needed with Oracle Forms 11g. Java plug-in is required on the client. Oracle certified Sun's JRE: 1.6.0.12 and higher Redesigned Web Layout – Implementation of NOAA-wide look and increased usability for the current web pages Addressed security issues on Web Pages Enhancements to Travel Document module Self-Service Password Reset Functionality. Users can reset their own passwords at anytime.

•	EA patch changes Doc Type and ARN for the documents started as EA that were not chained back to EA (problem with Certification of Obligations). For FY 2003-2009, we are planning on updating AP_Trans (and Reporting Table), without changing commitments data. For 2010, we are planning to re-create/update commitment data and to preserve obligations match status as much as possible.
