Open Issues / Discussion

- BOBJ Personal Category Issue – Penny
 - The BOBJ users have been asked not to use the Personal Category option within Business Objects until the team can correct a problem with this feature. Currently, if a user selects this option, the system will not allow the user to save a report. Subsequently, if the user saves a report that already has this flag set, they will need to uncheck it in order to save the report.
- Recertification Status – Gerald
 - The Recertification process was officially kicked-off 11/7/08. As we've been receiving the forms back, several questions and/or discrepancies have been discovered. For one, a few users are indicating that the forms do not mirror the access that they believe they should or shouldn't have. I've asked the users to mark up their form, sign it and send it in. We will take a look at these and possibly make the correction and resend the user an updated Recertification form.
- Open CCR's – A request by Gerald Thomas was made asking if we could distribute a list of active CCRs and their priorities. Gerald Stark will provide a listing. However as an FYI, within the Data Entry Module, CCR reports are available to all LO Administrators.
- Open Forum/Best Practices discussion – Gerald
 - Time did not allow for an open discussion on best practices or any type of demonstration. We will evaluate the submitted request for the next meeting schedule for 12/11/08.

NOAA Finance currently sends the high level report (P1) on a monthly level as a FYI. Each quarter, Finance determines which LO's are required to submit an explanation. The Line Offices then need a report that will allow the user to drill up/down to access where the variances exist. Start by listing and numbering all reports, group or categories each report, show duplication between each module, use the existing descriptions or develop comprehensive descriptions, provide sample screen shots, and then possibly provide a decision tree.
