Decision/Discussion Item

CCR1104 (RQ) Dinara Holmes – IT Cost Accounting (Additional Information) - In addition to the CCR # 989 & 987, we are providing a proposed structure-table to accommodate OAR's IT cost accounting reporting requirement.

Action: CCR1104 are additional requirements to be included with the approved IT-Costing CCR's 987, 989, and 1087.

CCR1164 - (RQ) Lisa Berry – IT Cost accounting for NWS – In conjunction with the new NOAA requirement of tracking IT costs in FY 2009. NWS requests that a crosswalk table be established identifying the 9-IT categories with the associated NWS Task Codes. To allow for the dynamic nature of weather activities the crosswalk table must permit NWS to add new task codes and/or change the percentage of IT costs on a quarterly basis. Action: CCR1164 are additional requirements to be included with the approved IT-Costing CCR's 987, 989, and 1087. Detailed requirements discussed at the meeting, relating to P00/F* Tasks, have been documented within the CCR.

CCR1124 (RQ) Peter Boyle – Remaining Commitment/Encumbrance Reporting - A programming change is required for the MARS Data Warehouse, in order to show Remaining Commitment/Encumbrance data amounts for the month just closed, on the first day after month end/General Ledger close, for the month just-closed. This change is required because the MARS MARS.Council@noaa.gov 2

Data Warehouse is currently designed based on an expectation the Month End Snapshot would be created late night of the last day of the month/GL Close, and then be available on the first day of the new month/after GL close (Feb 1st for Jan month end). But the Snapshot is actually not created until late night on the first day of the new month/ and not available until the morning of the second day (Feb 2nd). This lag under the current programming causes that data in Business Objects for Remaining Commitments and Encumbrances for the just-closed month to appear blank when reports are run for the just-closed month on the first day after GL close/month end.

Action: CCR approved by the Council, however as discussed, the MARS Technical group will evaluate the possibility of providing a preliminary data snapshot to be used to reconcile commitment and encumbrance information before being etched in stone through the snapshot process.

CCR1144 – (RQ) Dinara Holmes – Reimbursable Reporting - OAR would like to request Reimbursable Agreements Universe. What is the possibility of creating Reimbursable Funding queries? Presently neither of the modules provides the data needed such as Reimbursable Customer or sponsor, reports on Budget Initiative Number.

Action: CCR approved by the Council. First step, contact reimbursable POC's Lois Coleman or Candy Meyers to inform them of our intentions and to develop a working relationship with the Reimbursable group. Dinara will provide Discoverer workbook information so the technical team can identify the source tables.

CCR1146 – (RQ) Dinara Holmes – Reimbursable Reporting "NOAA Policy on Reimbursable Research by NOAA Labs" - Can the MARS team re-create tools or reports to assist with NOAA wide report named "NOAA Policy on Reimbursable Research by NOAA Labs". Its annual data call executed by each LO and compiled by OAR for the NOAA CFO Council. Presently few reports for this datacall exist in Oracle Discoverer, but run with difficulties and data needs to be often verified in CBS or MARS repetitiously. OAR requests to look into the option of creating few necessary reports for this NOAA wide exercise. I can provide the copy of the annual report at the request.

Action: CCR on hold (not approved) until CCR1144 solution identified.

CCR1147 – (DE) Sylvia Scott – DE Close Date - Revisit Software Council decision to close FY 2008 processing in Data Entry module. End result of decision is that prior years inaccessible through the data entry module. Users unable to access any data entry forms for prior years and therefore unable to easily find data through queries on data entry forms. Potential solutions (Just suggestions ... would like to hear other opinions): 1. Make data entry forms available but read-only (lock fields); 2. Create a report in Business Objects that gives uses a browse capability; 3. For commitments, some data-entry reports available, but not if parameter is name, remarks, description, etc. ... perhaps change parameters on report 6?

Action: CCR 1147 Approved by the Council. The team will evaluate several options to provide
