### **1. Suggestions for CCR system changes:**

- Report Selection for CCR status - add ability to choose ALL (open, closed, work-in-progress). Further discussion led to making this a multi-select process similar to selecting Fund Codes on data entry Rpt. 25 (i.e., user can select open and work-in-progress at the same time).
- Summary column: Needs to be more descriptive (i.e., Comments or Description Summary). Not currently on reports – needs to be added.
- BOBJ team needs to be included in the CCR Support role.
- Left justify description field on CCR reports.
