### **1. Consistency of MARS Terminology (Data Entry vs. BOBJ)**

BOBJ Report 118 column says ‘Commitments’ (per initial requirement) and displays the information from the MARS Pipeline column. BOBJ Commitment Detail

Universe has a Commitment field which is a total original commitment amount. It’s confusing for the reports users. MARS Data Entry Status of Funds Reports show outstanding commitment amounts under the ‘Pipeline’ header.

It was decided to change the name of the Report Column to ‘Remaining Commitment’ in both systems.

MARS Data Entry and BOBJ groups need to discuss the change implementation strategy.

### **2. Help Desk Issues**

- Per Carmen Solis, password reset procedures need to be checked. Per Nancy Majower, password reset should be completed within 4 hours same day unless reported after 5 pm.
- Nancy Majower will check the possibility of LO Administrators getting access to the C-Support system to monitor their requests.
- A technical discussion of the Help Desk changes and procedures will take place at the O&M MARS meeting next week.
- Help desk will check their screens to make sure that correct Line Office values are available to generate the tickets (instead of NMFS/Non HQ).

### **3. User Access Forms**

- Line Offices need to submit new User Access Forms to the Help Desk if there are changes in access to restricted labor data.
- There is a need for storing User Forms in a single database (it needs to be determined if CBS allows electronic signatures).
