CCR #58	Variance Reporting Status	Penny worked with a group of volunteers to test the proposed variance process to hammer out details to the user interface. Several changes were suggested and implemented during the test. We also received a few suggestions for improvement during the Council meeting demo, such as, a report to show transfers to other LO's.	<p>Penny will investigate an alternative to the comment update option where the user can make multiple changes without the screen being refreshed.</p> <p>The Reporting and Query Team will also complete work on Jim LeDuc's summary report, implement changes suggested by the Council and document the process with report descriptions and a users guide.</p> <p>The team will draft up additional guidance to be used by Jim LeDuc in order to implement the variance process. This will need to be done soon if we are to use the process against the May data.</p>
New	Fund Group Driller Report	Users can find this report under the "Higher Level Review" category in the Reporting & Query option in MARS. The report will allow you to view OR&F, PAC & Reimbursable Funds information at a high level or to drill down through the report to see detail.	The Reporting and Query team will add FTE information in the future. The Council approved the promotion of this report to production.
CCR# 202	Sponsor Code	On the Sponsor Code list of values found in the Commitment Form, is it possible to allow searches on the name and not just solely on the code?	Marina and the Data Entry Team will see if the agency/sponsor code is available in CBS. If so, we will use the data in the Data Entry Module as a look up to complete this CCR.

CPCS Update	CPCS Policy Change	Due to a policy change in the CPCS system, a sweep will be performed right after a bill comes in, thus creating an auto obligation against the default accounting codes. No longer will you have 7- 10 days to perform the reconciliation. Once the reconciliation is made and processed, the reversal will back-out the default transaction, creating a zero obligation.	Tonya and the Data Entry team will investigate this issue and report back with a recommendation. The policy change was discussed at the May 1 st Business rules meeting. Pending changes to NDW will tie entries together for improved tracking.
Travel Manager	Change in Travel Manager Reserve Trans Processing	A change in CBS with Travel Manager data is planned in the near future. CBS will be using the information in Reserve Trans to obligate travel. Currently MARS uses Reserve Trans to create commitments in MARS. In the future the system will automatically obligate these transaction.	Tonya will investigate the future change and report back to us at the next council meeting.
CCR 321	OPT Year End Clean-up	Each year within MARS, users will need to perform maintenance on the OPT table in preparation for the next FY. The MARS Data Entry team will be setting up the 09 codes that will allow MARS users to begin entering plans and/or labor projections. However, the team would like each LO to review their active codes in FY2008 and provide a listing of all codes that you DO NOT wish to convert to FY2009.	Tonya will be leading up this effort and will send out detailed instructions.
CCR 321	Labor Projection Setup	Also included with this CCR, the Data Entry team is preparing to set up the Labor projection data for 2009. The Team will use the projection rate for the last PP of 2008 or last available actual rate as a base for FY 2009. Copied projection profiles for projects not converted to FY 2009 will have invalid OPT and will be displayed on the "Employee with Invalid Info on the Projection Generation Data" Report.	Projections that have multi-line profiles will need to be confirmed by the LO to be converted over correctly. A report will be created by the Data Entry Team to assist with this verification. The Labor Generation Form will also carry a flag indicating multiple lines.
