CCR# 58 - Variance Reporting – Penny Schmiedeberg provided a demo of the new NOAA Variance Report. It was agreed by the group to perform a short pilot test on the new feature before moving forward and/or presenting to Jim LeDuc. LOs are encouraged to participate in the pilot test by sending an email with a list of testers to Gerald Stark. Access and instructions will be provided as soon as these names are received. The test has a short turn around as we need to receive feedback from the LO's before the next Council meeting.

NOA118 Report Discrepancy – Several users have noticed that the CBS Data warehouse 118 Report does not match with the MARS 118 report. The underlying cause of this problem is that the report cannot be filtered by a single ORG1. An action has been taken to evaluate the problem – CCR pending.
